Had a conversation the other day with a person excited to tell be that their thermal cup kept a beer chilled for five hours. My question was, who takes five hours to drink a bottle of beer?



FINANCE COMMITTEE REPORT – FINANCIAL YEAR ENDED 31 MARCH 2025

From Challenge to Change

Twenty months ago, the Club operation was unable to meet its financial commitments and was on the point of financial collapse. Member loans and debentures had propped the Club up but cashflow continued to be a serious issue. The repayment of the Ivor Walter Stickley Charitable Trust loan provided the funds to clear all outstanding debt, repay loans, attend to overdue maintenance, replace the ageing air conditioning system and provide cash flow while changes to operations were made. The remaining \$100,000 of the loan repayment funds are held on term deposit.

The 2024 accounts showed considerable improvement to the liquidity position, but the Club operations alone made a loss of \$212,034. This loss included a donation to the Poppy Trust of \$51,927. This accounting transaction was necessary to separate the Poppy Trust from the RSA trading operation. Removing this transaction, a loss of \$160,107 remained. The 2025 Financial Accounts for the RSA only (not including the Stickley Trust) show a loss for the year of \$144,934.

Over the past year the emphasis has moved from survival to recovery. Changes implemented saw the Club move from a cash operating loss of \$64,309 in the 2024 financial year to a cash operating loss of \$5,627 for 2025, just short of the goal of breaking-even from a cash perspective.

It is many years since the Club operation has returned a true profit. It has been slow to recognize and adapt to a changing business and social environment. Incremental changes to operations will continue but a clear strategy must be developed to align with Club goals and to address the financial challenges while maintaining the RSA ethos.

8. SUPPORT SERVICES

Activity

- We are still working with veterans regarding VA benefits. At times the response to requests has been slow, due to either the workload of the VA Case Managers, or to local contractors being unable to respond because of heavy current commitments. We have dealt with/are dealing with several veterans on matters relating to obtaining benefits or upgrading the range of benefits they currently access.
- Regular monthly visits to Rest Homes by the DSA, LSA and Volunteer Support Workers (VSW). There are currently 31 people of whom 4 are associate members, who we try to visit monthly to make sure the Club stays in touch with them, and to check if there are any issues that we can help with.

- Currently the DSA now visits one home, the LSA, three and our remaining 2 VSW's, two, rest homes, for a total of six rest homes being covered.
- One of our members in a rest home has died, and we have added three more people to our lists.
- We held a meeting for Support Advisers during the month.
- I am currently only trained to handle basic enquiries. To extend my competencies and allow me to process the more complex cases, I need further training, which can only be provided at a national level; this can only be finalized once the national RSA constitution issues are finalized allowing other details, including liaison with Veterans Affairs, to also be clarified. Until this can be organized, the DSA will continue to work with these cases for members of the Te Awamutu RSA. During the month I passed on details of one such reference to the DSA for follow-up.
- The Health Shuttle reports that they assisted 23 of our members with health visits to the Waikato Hospital and specialist appointments in May.
